

Unaddressed Deficiencies

- US 74 Business/US 76 Business (Jefferson Street)
 - In Whiteville, from 200 feet west of James Street to Franklin Street (SR 1953) is currently near capacity
 - currently a 2-lane roadway with a center turn lane west of Lee Street
 - widening this section of roadway impractical due to Lack of local support and the proximity of Section 4(f) properties
 - existing gridded roadway network provides alternate routes when this segment experiences congestion


Complete Streets Policy – some highlights


Why? Improve Vulnerable Road User Outcomes

Bicycle Crashes, 2014-2018




NC 8th highest rate of bicycle fatalities per capita
