To whom it may concern,

It has been brought to our attention that a round-about has been proposed for the intersection on 701, which is directly adjacent to our business. We are family owned and operated, and have been a community staple for 37 years and counting. The proposed round-about would greatly affect the very thing that our business needs to thrive: the traffic.

In an already shaky economy, small businesses are struggling enough without adding to it. We suffered a fire in 2018 which caused us to be out of business for months. Even after insurance claims, huge loans were still taken out in order to reopen. We were barely reopened for one year before the pandemic struck and shut us down to "take-out only"—which was followed by bare-minimum seating capacities for months after this. Since then we have battled through an unprecedented staffing shortage, as well. Now, hearing of this proposal that directly affects our small business yet again, we are pleading against it. We are actively trying to recover from all of the financial blows from the last few years.

During the high season, the beach traffic is often backed up in both directions every Thursday, Friday and Saturday. However, this traffic brings in a lot of business as travelers often like to stop in and take a break. The round-about would slow down an already congested intersection, causing people to become angry and less likely to stop in, or worse, reroute away from 701 altogether. I think the new pattern would contribute to more traffic accidents overall, as well.

We are pleading for other alternatives to be considered. As we have mentioned, we have dealt with many hardships the past few years. Please consider that the revenue we desperately need in order to stay in business could be greatly impacted by this decision.
