
INTRODUCTION

### **OVERVIEW**

The purpose of this report is to assess the feasibility of bicycle and pedestrian facilities along the NC 211 corridor (Southport-Supply Road) and to develop an implementation plan that fits the overall vision of incorporating alternative modes of transportation in eastern North Carolina. Brunswick County is one of the fastest growing counties in the state and is experiencing intense development challenges. The 17-mile NC 211 corridor proposed for this study is currently a two to three lane Minor Arterial that stretches from Fort Fisher Ferry, in Southport, to Stone Chimney Road. Proposed plans for this road include widening to a four-lane facility funded by the NC Department of Transportation.

This study also considers the overarching goal of connecting the East Coast Greenway (ECG) through coastal North Carolina. The ECG is a 3,000-mile greenway corridor stretching from Maine to Florida with a vision to provide fun, safe and accessible infrastructure for everything from a local commute to a long adventure. The Greenway will foster healthy, sustainable, and prosperous communities throughout the Eastern Seaboard. The ECG corridor will connect the Brunswick County Beaches with the City of Wilmington to the north and with Myrtle Beach, SC to the south. Recognition of this corridor for off-street bike and pedestrian facilities is supported by following previous planning efforts:

- Cape Fear Regional Bicycle Plan
- > Brunswick County Greenway, Bikeway, & Paddle Trail Plan
- > Brunswick County Parks and Recreation Comprehensive Plan
- East Coast Greenway Plan
- NC Bike Route 3
- > Gullah Geechee Cultural Heritage Corridor
- NCDOT NC 211 Widening Project (R 5021)
- Southport Bike Map



### **PROCESS**

The feasibility study process is one of transparency, community engagement, and data driven recommendations developed through an analytical, need-based approach. From the initial inventory and analysis through the implementation plan, the project team engaged the community, stakeholders, and Cape Fear Rural Transportation Planning Organization (Cape Fear RPO) staff.

The project team began with an intensive exploration phase to develop a detailed understanding of how residents want to move and where they want to go. This phase also included specific work undertaken by surrounding municipal agencies to create a coordinated approach to creating a connected, safe network.

The analysis phase of the project examined the overall network, context, current planning efforts by other agencies, and project team site visits to areas considered for potential corridor options. The network analysis resulted in a plan that connects desired destinations with a mix of greenway trails, side paths along roadways, and improvements to existing roadways that currently do not support separated bike and pedestrian facilities. The project team investigated each proposed corridor alternative to determine ideal alignment of trails, location of supplemental facilities, as well as constraints that will need to be overcome.

Finally, the project team, in conjunction with RPO staff, developed and prioritized recommendations to improve the pedestrian and bicycle facility offerings. The study includes:

- > Existing conditions evaluation
- Identification of opportunities and constraints
- > Trail alignment, trail surfacing, and access point recommendations
- > Identification of opportunities for new passive open spaces along recommended trail alignments
- Potential acquisition opportunities
- > Identification of connection opportunities with roads, sidewalks, bicycle routes, neighborhoods, and business hubs
- > Development of preliminary design and cost estimates
- > Creation of an achievable plan with prioritized phasing




#### **PROJECT VISION**

This feasibility study is intended to evaluate the corridor's ability to accommodate dedicated bicycle and pedestrian facilities and to maximize its potential as an integral segment of the East Coast Greenway and the state bike route system.

#### **GOALS**

- > Fill in the significant gap that currently exists in developing the East Coast Greenway corridor through coastal North Carolina area.
- Provide regional connections to parks, commercial destinations, local businesses and community recreation resources (such as beaches, the lighthouse and historic district) within the downtown Southport area.
- Provide opportunities for users to experience the flora and fauna within the diverse habitats of the coastal environment.
- Enable the County to achieve their vision of a connected pedestrian and bicycle transportation network by identifying feasible, constructible routes.
- > Establish specific connectivity recommendations.
- Create an implementation strategy that aims to reduce vehicular congestion by providing desirable pedestrian and bicycle connections to safely move users to desired destinations.
- Provide recommendations to construct a multi-modal transportation system that augments tourism efforts, giving visitors more opportunity to explore and experience Brunswick County.
- Convey recommendations to aid in communication, coordination, collaboration, and prioritization of planning efforts and initiatives that fill the gaps to avoid transportation silos.
- > Inform development and infrastructure investment decisions that support the integrated and connected multi-modal transportation system.





#### **OBJECTIVES**

To achieve the goals set forth by this feasibility study, the project team identified the following objectives:

- > Utilize previous planning efforts and precedent studies to ensure consistency in considering proposed corridor routes.
- > Recommend possible trail alignments that connect diverse destinations.
- > Seek opportunities to create small area trail loops (such as the downtown Southport loop) to connect historic district, other tourist destinations, and downtown businesses.
- > Recommend trail surfacing and access points.
- > Identify opportunities for new open spaces along the trail alignments.
- > Identify opportunities for environmental education along sensitive coastal environments.
- Identify potential acquisition opportunities.
- Develop preliminary designs and cost estimates.
- Create an achievable plan with prioritized phasing.
- > Provide recommendations that support desired infrastructure and economic development as well as environmental needs and requests.
- > Foster a healthy community by providing resources that aid in the development of recreational opportunities and access to open space.




#### **PROJECT CONTEXT**

NC 211 is the primary route from the Town of Aberdeen in Moore County to the City of Southport in Brunswick County. It traverses the Sandhills and Coastal Plain region of the state in a southeast/northwest direction. Some of the major destinations along this route include Pinehurst, Aberdeen, Raeford, and Lumberton to the Southport area and the surrounding beaches.

NC 211 (Southport-Supply Road) is currently classified by NCDOT as a minor arterial road. Starting at the project area off Highway 17, this 17-mile corridor provides connections to St. James, Holden Beach (Via Sabbath Home Road link to Stone Chimney Road), Varnamtown (via Stone Chimney Road), Oak Island, Caswell Beach, and Southport. Land use along the corridor varies and includes a mix of businesses, residential subdivisions, schools, community facilities, agricultural uses, and vacant properties. Predominant features along the corridor include a Duke Energy easement that runs parallel to the road and the presence of wetlands and stormwater conveyance swales in certain areas. The roadway typical cross section generally includes two-lane traffic and narrow shoulder areas, with major intersections expanded to accommodate turn lanes and associtated medians. This section of NC 211 is also considered an evacuation route for coastal communities.

NCDOT has funded a portion of NC 211 for expansion from a two-lane to a four-lane highway to alleviate traffic congestion. The approved plans show sidewalks along the route but no dedicated facility for bicyclists. Considering the heavy traffic on this route, the project team and stakeholders decided to expand the study area to include alternative routes south of NC 211 and evaluate the feasibility of dedicated off-street pedestrian and bike facilities. As shown in the full build out exhibit, the area around NC 211 is facing challenges that come with new developments and population growth.



# **EXECUTIVE SUMMARY**

The NC 210 East Coast Greenway (ECG) Feasibility Study assesses existing conditions, evaluates potential routes for opportunities and constraints, develops detailed cost estimates, and provides strategies for implementation. The study also provides insight into previous planning efforts such as the Mountains-to-Sea Trail (MST), the ECG, and the Gullah Geechee Trail. The project team assessed several routes along roadways in Pender County and the Town of Surf City, mainly along NC 210. The study proposes a preferred alignment with potential connector routes.

This study includes a Steering Committee, stakeholder and public engagement, and a strategic engagement plan to coordinate with landowners. An existing conditions analysis, including an extensive Geographic Information Systems (GIS) analysis with base mapping, parcel-by-parcel analysis, and examination of environmental features and topography is used to understand opportunities and constraints associated with the study area.

Alternative trail route scenarios with the identification of landowner and acquisition challenges, road and stream crossings, and environmental and permitting constraints are provided. Route scenarios were narrowed to one preferred route through community and stakeholder input.

The preferred route includes the development of acquisition strategies, planning-level cost estimates, and project phasing. An implementation plan, along with action steps and funding resources are provided at the end of the document.

## PREFERRED ROUTE

The preferred route (featured right) will provide users with a safe path, separated from roadway traffic, for approximately 16 miles from Nelva Arberry Park in Surf City to Country Club Road in Hampstead. The route consists of road adjacent sidepaths, boardwalks, bridges and some scenic greenway segments. A number of key connectors off the main route are also recommended, to support community interests in reaching shopping and recreation destinations and to recognize the priorities identified by the Steering Committee. The preferred alignment was divided into six segments, for ease of implementation, which are described in detail in Chapter 5 and briefly below:

- Segment 1 Sidepath; New River Drive and North Topsail Drive from Nelva Arberry Park to NC 210
- Segment 2 Sidepath; Roland Avenue at Surf City Bridge to NC 210 at Caretta Drive (future)
- Segment 3 Sidepath, Greenway, Boardwalk; NC 210 at Caretta Drive, north to Duke Energy easement, west just north or Electric Lane to Alston Boulevard Extension
- Segment 4 Sidepath, Greenway, and Boardwalk; Alston Boulevard Extension to US 17 and down Sloop Point Road
- Segment 5 Greenway, Boardwalk,
   Sidepath; Sloop Point Road to Sloop Point Loop Road at Hampstead Kiwanis Park
- Segment 6 Sidepath and retaining wall;
   Sloop Point Loop Road at Hampstead
   Kiwanis Park to Country Club Road at NC17

# TOWN OF SURF CITY ALTERNATIVE ROUTES

During the late stages of the planning process, the Town of Surf City decided to evaluate three (3) additional alternative routes as part of the mainline for the greenway. These segments are described and displayed in the cutsheet maps in Chapter 5 (Implementation); however, they were not analyzed as part of this feasibility study.

Please accept this letter of support for the Growing Rural Equity and Access to Transportation in North Carolina (GREAT-NC) application to the USDOT's 2023 Neighborhood Access and Equity (NAE) Program's Regional Partnerships Challenge Grant. GREAT-NC is partnership between North Carolina Department of Transportation (NCDOT) and the Great Trails State Coalition (GTSC), a diverse coalition of 87 agencies, municipalities and organizations advocating for increased state investment in all forms of non-motorized trails in North Carolina. GREAT-NC will address the persistent regional mobility challenge that North Carolina's rural, disadvantaged communities face in accessing federal funding to retrofit roads with safe biking, walking, and crossing infrastructure.

Historically, North Carolina's pattern of rural road development has systemically favored automobile travel at the expense of access for pedestrians and cyclists. This practice divided rural communities with high-speed, high-traffic roadways which typically excluded facilities for biking and walking. Compounding this challenge, in 2013 North Carolina lawmakers prohibited state funding for independent bicycle and pedestrian projects. As a result, rural and disadvantaged communities have fallen further behind communities with more resources when it comes to the design and construction of biking and walking facilities.

GREAT-NC will address these disparities by creating a construction-ready pipeline of approximately 148 miles of pedestrian and bicycle facilities found in the Great Trail State Plan and located in economically disadvantaged, rural communities, while building local capacity for project delivery to support the creation of safe and equitable bicycle and pedestrian access to daily destinations in rural North Carolina GREAT-NC will create context-sensitive transportation solutions that are more affordable, safe, and accessible for all.

Capitalizing on the momentum generated by the Great Trails State Plan and the designation of 2023 as North Carolina's "Year of the Trail" by the North Carolina General Assembly, NCDOT and GTSC will establish a robust capacity building program that includes a statewide conference,

the creation of technical assistance positions to directly support communities implementing GREAT-NC projects, and the convening of the Cities, Towns and Counties for Trails Working Group to serve as a peer group for participating communities.

In the Cape Fear region, there is significant commitment to multimodal transportation infrastructure but, for the reasons listed above, we have difficulty obtaining funding beyond the planning phase and into design and construction. In 2021, the Cape Fear RPO completed a feasibility study for the East Coast Greenway alignment that goes from Southport to Supply, a facility that is a critical transportation and economic development resource for a county that is among the fastest growing in the nation. The Cape Fear RPO is committed to developing projects that improve the quality of life for our residents, and the projects included in this GREAT NC application would be transformative for our communities.

Thank you for your consideration of the GREAT NC application for funding through the NAE Regional Partnerships Challenge program.

#### SEPTEMBER TPD UPDATES CAPE FEAR RPO

#### SEPTEMBER 2023

**Brunswick County Comprehensive Transportation Plan (CTP)**: The last steering committee meeting was on June 27<sup>th</sup>, where the committee made decisions on public involvement feedback. Updates to the report and appendix were made during the month of July by TPD engineer and submitted to TPD management in early August. Currently, the CTP is being reviewed by TPD management. After reviews are complete, report and appendix will again be updated, and TPD engineer and RPO planner will start preparing for local adopting agency presentations.

Columbus County Comprehensive Transportation Plan (CTP): The engineer is updating the V/C maps, crash maps, and highway network from a base year of 2015 to 2021 and reprojecting to the same future year of 2045. Capacities are being updated from 2000 HCM to 2010 HCM. The final steering committee meeting was on May 4<sup>th</sup>. Adoptions are anticipated to be held in the fall.

**Pender County Comprehensive Transportation Plan (CTP):** The Pender County CTP will start in fall of this year. The last Pender County CTP was adopted in 2015. The base year for this CTP will be 2021 and horizon year will be 2050.

Wilmington Travel Demand Model (TDM): Recently, the Wilmington MPO verified base year socio-economic data for the TDM. Currently TPD is waiting for the Wilmington MPO to submit additional data before moving onto completing Base Year Estimates for the TDM.
