I. Sub-Committee Reports

- A. Veterans Strategy Committee Met April 27th at 11am. Betsy Graham with NHC Veteran Services presented about her organization. We also started working on action items from our strategic Plan.
- B. Oversight Committee The Oversight Committee met in February to discuss the follow-up to the monitoring audit completed at CFHIL by Judy. She requested a response to the findings but never received it. Based on this, the Oversight Committee recommends that CFHIL be ineligible for future HUD or ESG funding until all requested documents are submitted and the 2022 monitoring visit by the CoC is considered completed. We will notify the CoC when a meeting is scheduled.
- C. Coordinated Entry Met April 17th. Committee members review and make revisions where appropriate on joint documents prior to next meeting. Continue to work towards proposed finish of revisions by June committee meeting. Propose May 9th as restart date. Have training prior to meeting as a kickstart
- D. By-Law Committee Our committee has not met as there are currently no new additions and/or changes for Governance and Structure.
- E. Housing Choice Voucher Committee Met May 11th. The group continued reviewing the current MOU between the CoC and Wilmington Housing Authority to clarify roles and responsibilities and ensure that the process of submitting documentation and tracking vouchers is clear and efficient.
- F. Ranking Committee Met May 9th. The committee began reviewing the narrative questions for the COC scorecard. The recommended changes to the COC Written Standards will be sent out to the Board for their review prior to the 5/18/23 meeting. Judy asked that the committee make a recommendation to the Board at the 5/18/23 meeting regarding community priority categories so they can be shared with potential applicants prior to the expected NOFO drop date of 6/5/23. Jamie Stokley had to resign from the committee as she plans on applying for either ESG or COC funds. Chianti Johnson from COW joined the committee today to start familiarizing herself with the COC and the Ranking Committee. The Ranking Committee would also like to recommend for the Board's approval the following community priority categories for the 2023ESG Grant competition: Homelessness Prevention, Street Outreach,

Emergency Shelter and HMIS. While applicants may submit applications for funding in all ESG eligible categories, the committee is recommending that applicants be incentivized to apply in these categories through points awarded for submitting project applications for one of the focus categories.

- G. HMIS Committee HMIS Committee did not meet in April. Our next meeting is May 24th at 2pm. The meeting will be virtual.
- H. Structure Committee Our committee has not met as there are currently no new updates.

II. New Business

- A. Andrea Stough made a motion to approve Kyle Abrams as the new Secretary of the Board, 2nd by Tufanna Bradley, motion passes.
- B. Michele reminded the Board and public attendees that Board Nominations are due by April 18th. There will be a vetting period after that, but before the May 2nd Annual Meeting.
- C. Tufanna presented on the Getting Home program. She will share the all the numbers she reported on during the meeting to Judy to share with the CoC. She shared Katelyn Maddox is the program lead. A few numbers that were reported were:
 - a) 61 individuals accessed shelter

- b) 5 individuals housed
- c) 11 people found employment
- d) 11 people unified with family
- e) 27 users of the Bin Den
- D. Annual Meeting will be held on May 2nd at the Brunswick Senior Building from 9am to 12pm. Pastor Rob Campbell will be the Key Note speaker. There will be a Data discussion, Nominations and the Executive Committee will be voted on, and there will be snacks. Board Members must attend.
- E. Kyle made a presentation on the Strategic Plan the Veterans Strategy Committee has been working on. It involves goals, outcomes and action items to achieve these goals. Kyle Abrams made a motion to approve the plan, Leslie Smiley 2nd, motion passes.
- F. Kyle made a presentation Permanent Supportive Housing data. PIT Count data from 2010 to 2022 was used to show that our overall homeless population has decreased by 50% since 2010. The data shows that when permanent Supportive Housing becomes available the Chronically homeless population has decreased.
- G. Laura discussed the upcoming forum on homelessness that Vigilant Hope is hosting at the Harrelson Center on March 20th at 6:30pm. There will be a presentation on the data of homelessness, projects already going on to combat homelessness, and a panel including government officials, local service providers and an individual with lived experience.
- H. Audrey Hart with the Emergency Management department presented on what services they provide. Audrey discussed what homeless services are provide in extreme weather and what services they provide. This includes Cooling Stations, Shelter, White Flag, provided supplies to other shelters. She explained that Emergency Management helps during extreme weather, hurricanes, natural disasters, and hazmat situations. The Emergency Management Committee meets virtually every other month from January to June, then during Hurricane season they meet every month.

III. Public Comment

A. Allen Serkin, Executive Director of the Cape Fear Council of Governments, feels PSH rental assistance isn't overly expensive, actually very affordable. Tenant assistance is paying for profit companies and private landlords in our community, creating a cycle of investment in the community. We need to look at how we divide our Federal Funds.

- B. Katrina Knight, Executive Director of Good Shepherd Center, announces that the Cape Fear Housing Coalition is hosting their annual breakfast on march 23rd at UNCW. Please RSVP ahead of time. The author of The Affordable City will be speaking. Katrina also feels our community has done a good job education elected officials. However, the city presented what they plan to do with HOME-ARP funds and a City Council member disagreed with Housing First Best Practices and PSH., which is concerning to her. She encourages people to reach out to the City Council in support of the City Staff's plan.
 - 1. Michele encouraged attendees to email city council in support of the plan.
 - 2. Andrea Stough made a motion that the CoC sends correspondence to the Wilmington City Council in support of the City Staff's plan. Meg McBride 2nd, motion passes unanimously. Michele will write the letter.
- C. Pastor Rob Campbell, with New Beginnings Church, feels we need to do a better job of building relationships with government staff that are on the Board.
