The Cape Fear Rural Planning Organization (CFRPO) is seeking approval for the amended FY 23-24 Planning Work Program. RPO staff deemed this necessary to align the PWP categories with the work priorities across the region. The changes have been reviewed by the Cape Fear Rural Transportation Advisory Committee (RTAC) on June 14, 2024. There is no change to the RPO's overall budget.

The changes that are being proposed:

II-3 Program and Project Development – decreased by \$2,000.00 since more time was spent on Project Prioritization compared to Project Development in FY23-24. At the end of FY24-Q3, only 37% of the budgeted amount in this category had been spent.

Funding was transferred to:

II-2 Prioritization – increased by \$2,000.00 to account for time spent analyzing P7.0 Quantitative Scores and assisting RPO members through the P7.0 Regional Impact Local Input Point assignment process. At the end of FY24-Q3, 94% of the budgeted amount in this category had been spent.

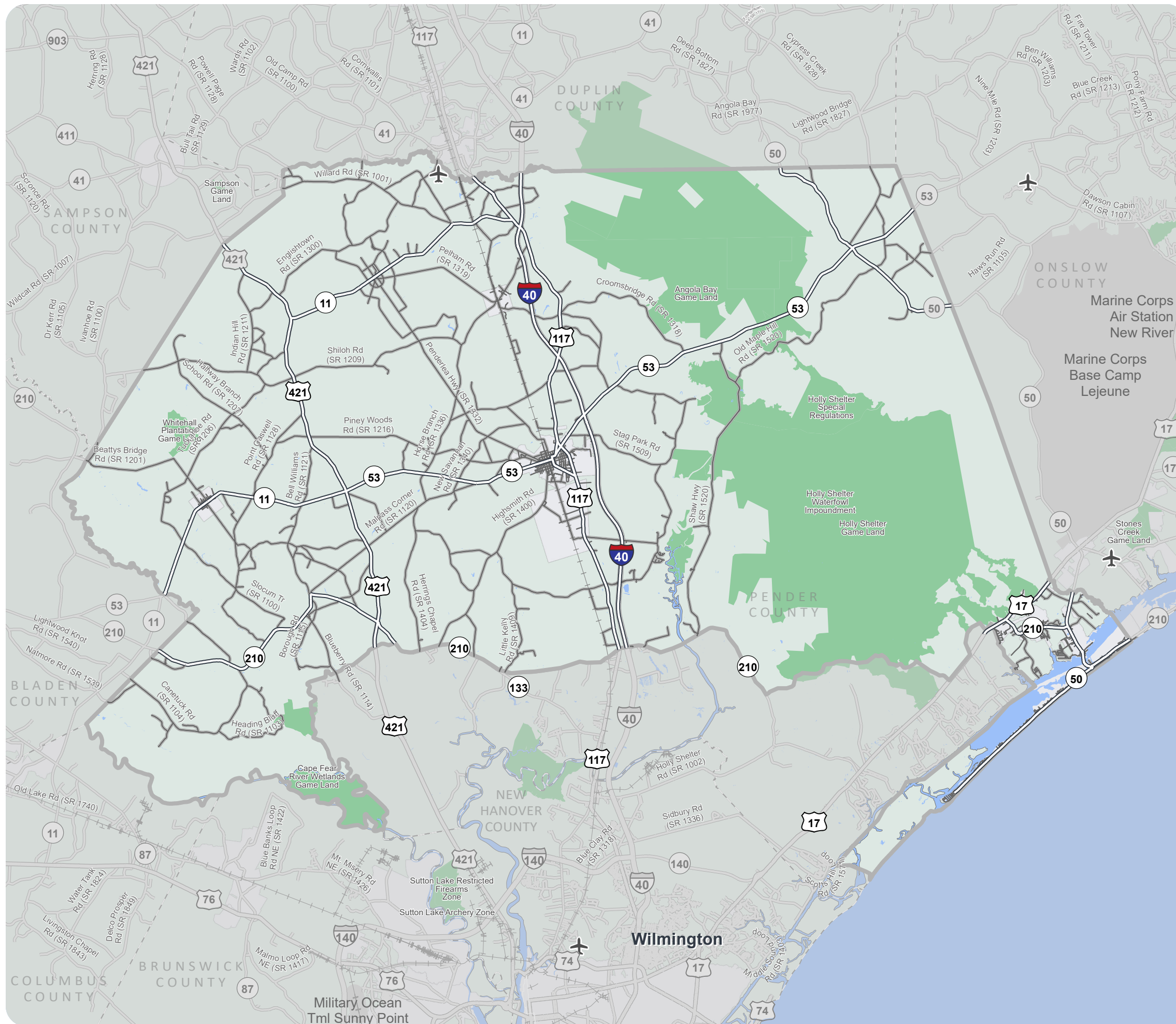

RE: Prioritization 7.0 Quantitative Scores

On Friday, May 24, 2024, NCDOT released the **Prioritization 7.0 Quantitative Scores**. For eligible Statewide Mobility projects, NCDOT also indicated whether projects scored high enough to be selected for funding in the Statewide Mobility funding category in the Draft 2026-2035 STIP. Preliminary schedules for selected projects are not available at this time but will be provided with the release of the Draft 2026-2035 STIP in January 2025.

Along with the quantitative scores for P7.0 projects, NCDOT also provided projections for funding availability in all 22 STI funding categories (Statewide, 7 Regions, and 14 Divisions). Variables considered in these projections include estimated revenues over the 2026-2035 time period, amount reserved for inflation, variance adjustments, and amounts programmed on committed projects. These projections will continue to change over time, and staff will keep RPO members informed so that we can factor funding availability into our Local Input Point Methodology.

The **P7.0 Regional Impact Local Input Point** assignment window began on Tuesday, May 28th and ends on Wednesday, August 28th. As stated in our Methodology:

“Each county RTCC representative will assign every project within the county a HIGH, MEDIUM, LOW, or NONE priority classification for each tier at which the project competes. County RTCC representatives should assign priority classifications such that projects are distributed with an approximately equal number of projects in each classification.”

RPO staff will coordinate with each County to determine project priorities for P7.0 projects before the RTCC and RTAC August meetings.

Quantitative Scores for projects within the Cape Fear RPO planning area will be made available on the RPO’s website in the **Project Prioritization** page in early June.
