Area Agency on Aging

The Area Agency on Aging (AAA) is the organization mandated by the federal Older Americans' Act to advocate for older adults in the four-county area through program administration, planning and development. Federal, state, and local funds support the following services delivered within the region: congregate and home-delivered meals; transportation; in-home aide services; legal assistance; adult day care/day health; senior center operations; information/case assistance/options counseling; and health promotion/disease prevention. Other services administered by the AAA include the services of two Regional Long-Term Care Ombudsmen who serve as advocates for long term care residents and work to resolve complaints made by or on behalf of these residents. The AAA also administers the federally mandated Family Caregiver Support Program which provides information, education, and limited respite service to caregivers of older persons. A fully state funded program, Project C.A.R.E. (Caregiver Alternatives to Running on Empty) is a dementia-specific support program for family caregivers. The program, covering a twelve (12) county area offers the services of a family consultant to provide comprehensive support to caregivers of those with Alzheimer's disease or related dementia in the home setting. The AAA also administers grants for educational information to Medicare beneficiaries of Medicare Part D Rx Drug Plans and the Senior Medicare Patrol Program, a fraud prevention educational program. The AAA facilitates the Cape Fear Elder Abuse Prevention Network, a four-county multi-disciplinary initiative to increase awareness, identification & reporting of elder abuse, neglect, exploitation.

FY 2019-2020 HIGHLIGHTS

- Home and Community Block Grant funds facilitated the delivery or serving of approximately 336,781 meals, 16,463 vehicular trips to medical care, grocers, pharmacies and adult day care operations; provided 1,174 days of adult day care; provided 208 older adults received legal services; 40,485 hours of in-home aid services.
- The Long-term Care Ombudsmen provided 28 educational trainings for facility staff; fielded 390 complaints with 234 cases/complaints closed; made over 432 facility visits and provider consultations; serving a total of 352 clients. The Community Advisory Committees donated volunteered 400 hours visiting facilities.
- Project C.A.R.E (Caregivers Alternative to Running on Empty) Family Consultant served 90 caregivers of persons with dementia in 12 counties with 353 hours of case management and awarded 112 vouchers (\$500 each) for respite.
- Family Caregiver Support Grant Program provided information/assistance and educations to approximately 793 caregivers giving needed resources and knowledge to enhance their abilities; provided direct services such as Support Groups, Respite, Supplemental Support to 275 caregivers.

Tri-County Homeless Interagency Council

The Tri-County Homeless Interagency Council (Tri-HIC) is the Cape Fear Area's HUD-approved homeless Continuum of Care (NC-506). The Tri-HIC is an alliance of service providers, local government agencies, and other public interests whose common goal is the reduction and ultimate elimination of homelessness in the Cape Fear Region. Beginning in 1995, HUD encouraged the establishment of Continuums of Care (CoC) in order to coordinate services and housing resources for those experiencing homelessness. The CFCOG serves as the Tri-HIC's administrative home, providing staff and fiscal sponsorship support to the CoC alliance. On an annual basis, staff organize and coordinate national grant competitions with the community, bringing in approximately \$850,000 in federal, state, and local funds to provide emergency services and housing to individuals and families who are homeless.

In addition, the CoC staff works with the Tri-HIC to implement and create best practices disseminated from HUD to end and prevent homelessness in communities. The CoC staff manages the homeless response system known as Coordinated Entry, which is the process by which individuals experiencing homelessness are linked to services such as housing. The Coordinated Entry system is designed to serve the most vulnerable with the highest needs. The CoC Department serves as the Database Administrator for the Homeless Management Information System (HMIS) which is used with Coordinated Entry for tracking outcomes and submitting federal and state reports. The CoC staff coordinates the annual Point in Time Count with the community, which is a 24-hour period in January of surveying sheltered and unsheltered individuals.

FY 2019-20 HIGHLIGHTS

- Implemented a new homeless response system called Coordinated Entry and enrolled 652 individuals to assist with agency referrals, permanent housing, and other necessary community services.
- Utilized our database system and weekly meetings to determine that nearly 55% of people have left the Coordinated Entry Program due to a housing intervention, securing of permanent housing, and left the area or passed away.
- Implemented a new Coordinated Entry Hotline model to improve accessibility among the CoC coverage area.
- Formed the COVID Homeless Task Force during the COVID-19 pandemic to establish protocols and policies for the Healthy Hotel Model and increase collaboration among local community agencies and stakeholders.
- Coordinated over 2 million dollars to local homeless programs from North Carolina CARES Act funding including Street Outreach, Emergency Shelter and Rapid-Rehousing Assistance.



Local Government Services

The Local Government Services (LGS) department provides member governments with a wide variety of services in four broad categories: Management, Planning, Transportation, and Data & Mapping. The department provides knowledge, experience, and manpower to supplement and extend the abilities of member government staff to meet the many needs of local government.

Management services include a number of products including personnel and pay studies, codes of ordinances, human resources and financial consulting, infrastructure asset management planning, grant writing and administration, and training and retreats for elected and appointed boards.

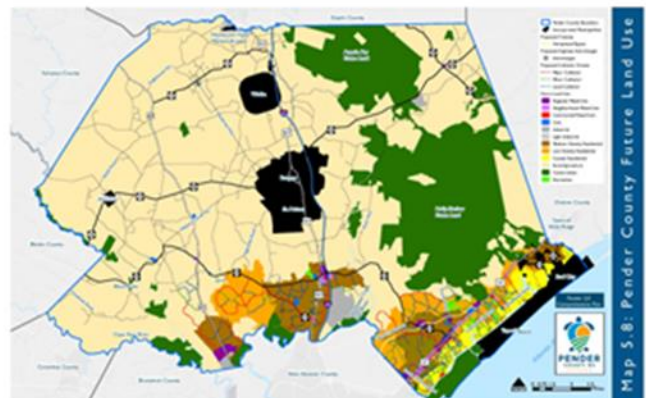
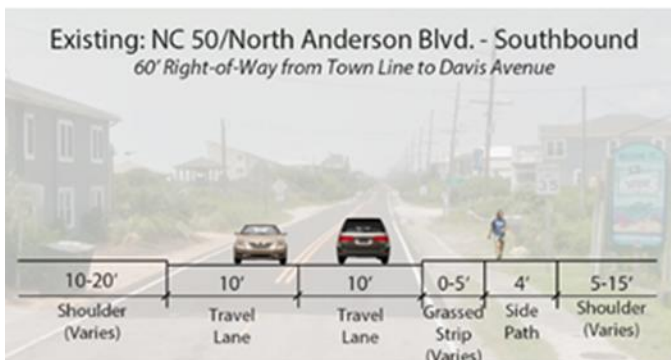
Planning services include long-range planning activities such as comprehensive plans, land use plans, hazard mitigation plans, park and recreation master plans, small area plans, and special studies; and current planning activities such as development review, development regulations, and zoning administration.

Transportation services include staffing and administration of the Cape Fear Rural Transportation Planning Organization (RPO), which provides transportation planning and advocacy for our non-metropolitan areas, as well as special transportation studies like corridor plans, bicycle and pedestrian plans, and parking and sidewalk inventories.

Mapping, Design, and Data services include GIS mapping and spatial data analysis; GPS data collection and infrastructure mapping; 2- and 3-dimensional renderings, visualizations, and other conceptual designs; and data access and management consulting. In addition, we develop and maintain several spatial databases of local facilities like sidewalks and parks, as well as serving as the regional State Data Center Affiliate.

FY 2019-20 HIGHLIGHTS

- Served as Disaster Recovery Coordinators to assist with a regional needs' assessment and grant preparation.
- Assisted with the update, rewrite, or review of development codes for the Towns of Topsail Beach, Shallotte, Fair Bluff, Navassa, and the City of Southport.
- Served as on-call Planning & Zoning staff for multiple communities and provided elected official and board trainings for more than a dozen communities.
- Provided outreach and local government training to more than 250 staff members, elected officials, and stakeholders.
- Secured funding for a Feasibility Study of the East Coast Greenway route along NC 211 in Brunswick County.



Workforce Development

The Cape Fear Council of Governments administers the federal workforce programs authorized by the Workforce Innovation and Opportunity Act (WIOA) that help job seekers access employment, education, training, and support services to succeed in the labor market and match employers with skilled workers they need to compete in the global economy. A cornerstone of the public workforce investment system in North Carolina is the NCWorks Career Center which brings together key employment, education, and training programs. An NCWorks Career Center is located in each of the counties of the Cape Fear Region.

The CFCOG Workforce Development staff work at the direction of the Cape Fear Workforce Development Consortium Board and the Cape Fear Workforce Development Board (CFWDB), which is responsible for planning and oversight to workforce activities for jobseekers and employers across our region. The CFCOG is responsible for allocating resources and monitoring program activities to ensure program quality and effectiveness.

FY 2019-20 HIGHLIGHTS

- Assisted more than 16,000 jobseekers and provided over 25,000 services to employers on-site and virtually through our regional NCWorks Career Center system.
- Launched the first virtual CFCOG Regional Youth Summit. Ninety-four youth participated in the event which included six guest speakers and virtual activities. NCWorks provided ongoing virtual workshops centered on work-readiness and career exploration.
- Supported the creation of a Sector Partnership in Manufacturing, which convenes leadership from regional manufacturing companies to address industry-specific needs. The CFWDB and its regional economic development and community college partners were awarded this opportunity by the North Carolina State Sector Strategy Council.
- In response to the pandemic, the CFWDB was awarded a special grant to support sanitization positions for eligible regional companies and agencies. The NDWG COVID-19 grant provided subsidized employment for individuals adversely impacted by the pandemic.
- Implemented the Incumbent Worker Training Program across the region to support companies with layoff aversion and expansion by training its existing workforce.
- Provided emergency assistance to community college students across the CFCOG region through the North Carolina Finish Line Grants program, which enrolls eligible students into NCWorks training programs that provide career guidance for employment upon graduation.
- Collaborated with other agencies to maintain MyFutureNC as a priority for programs funded through the CFCOG for NCWorks. MyFutureNC is a statewide initiative to attain 2 million post-secondary credentials in high-growth sectors by 2030.

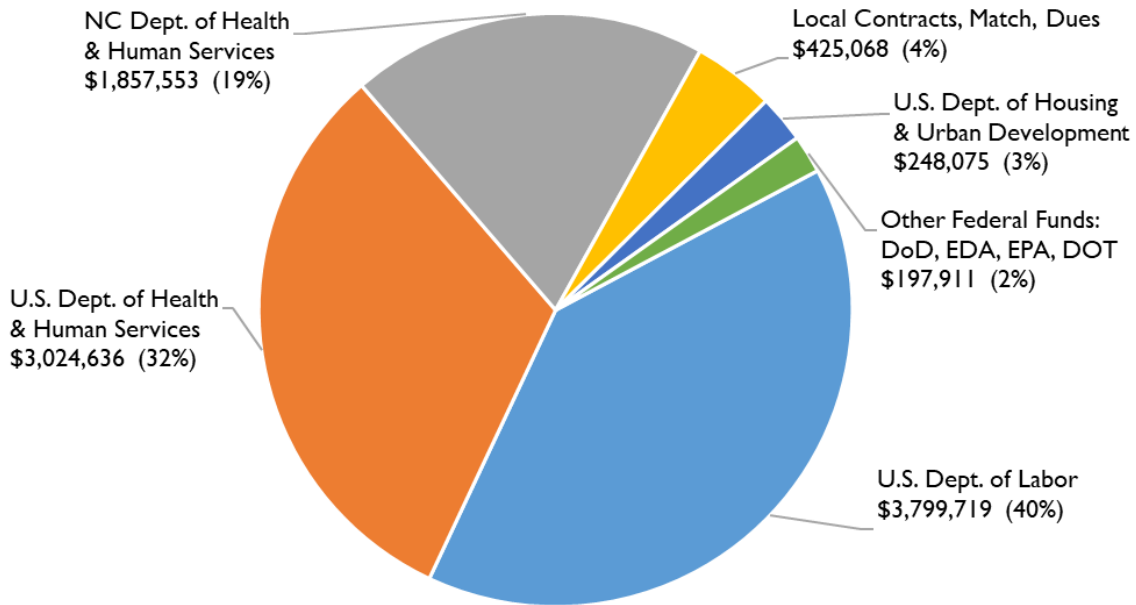


Administration

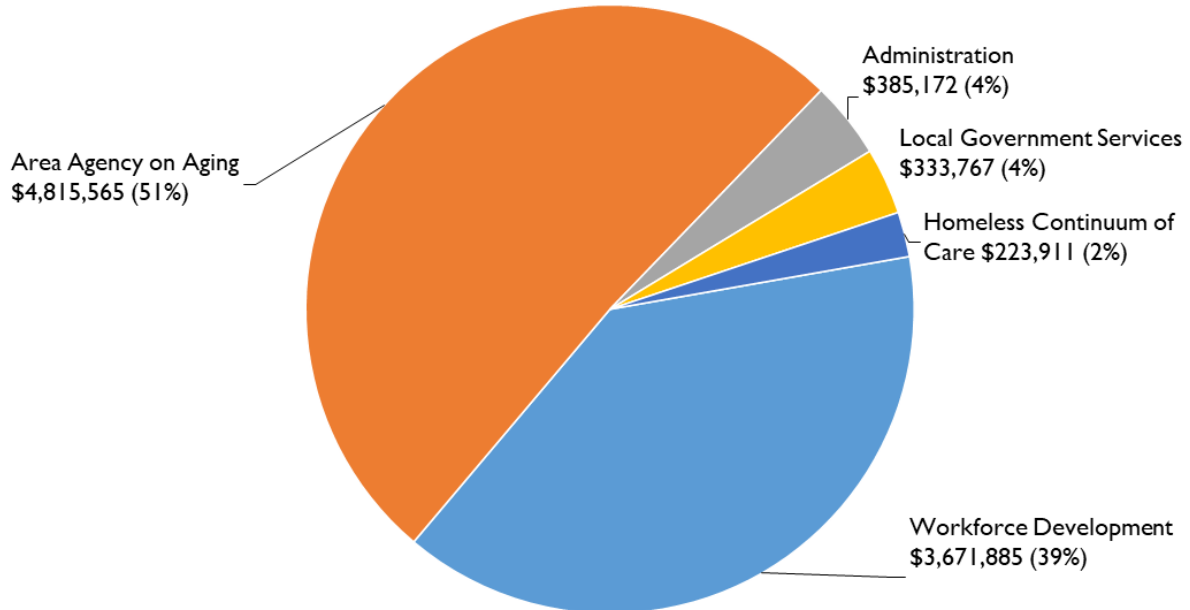

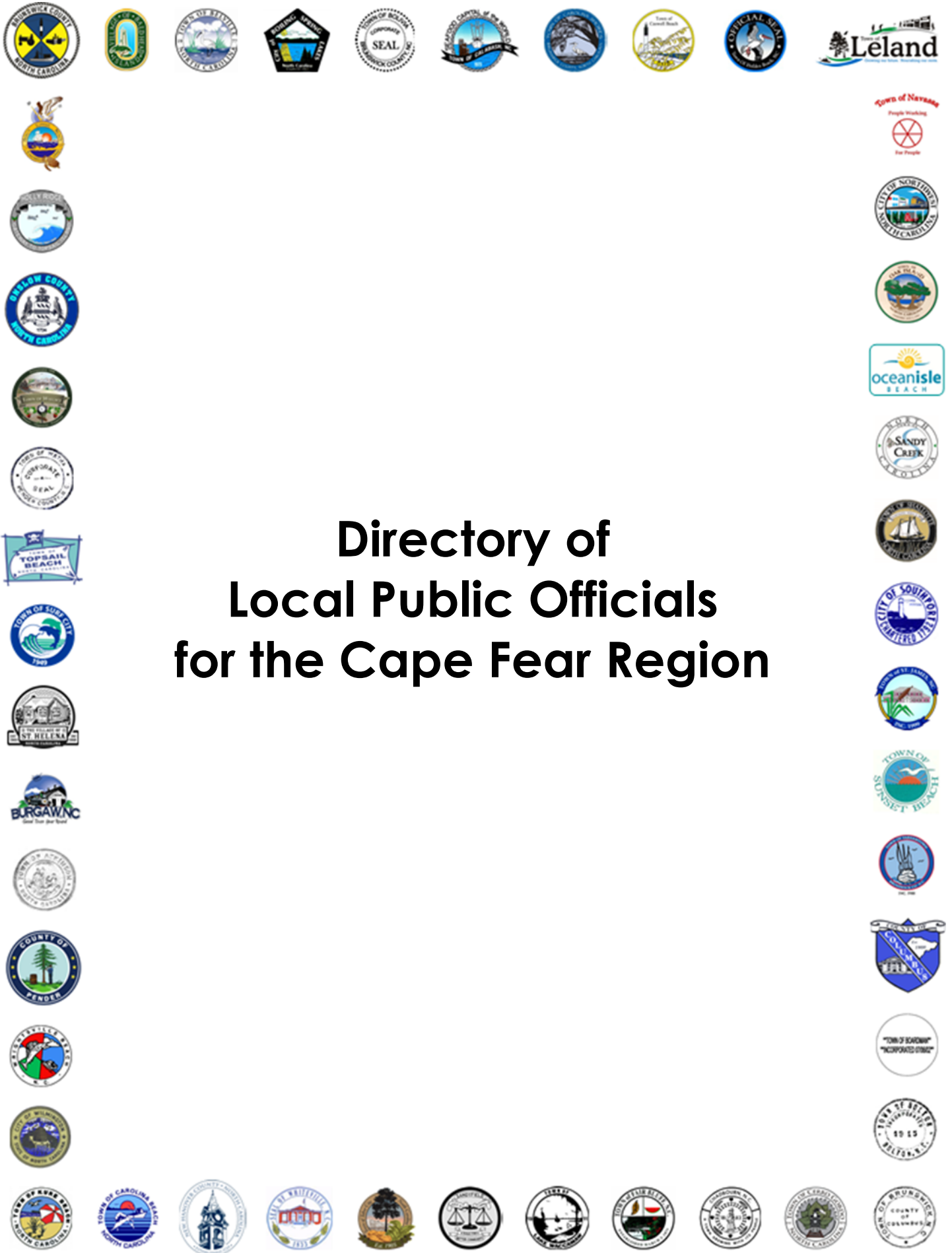
FY 2019-20 HIGHLIGHTS
