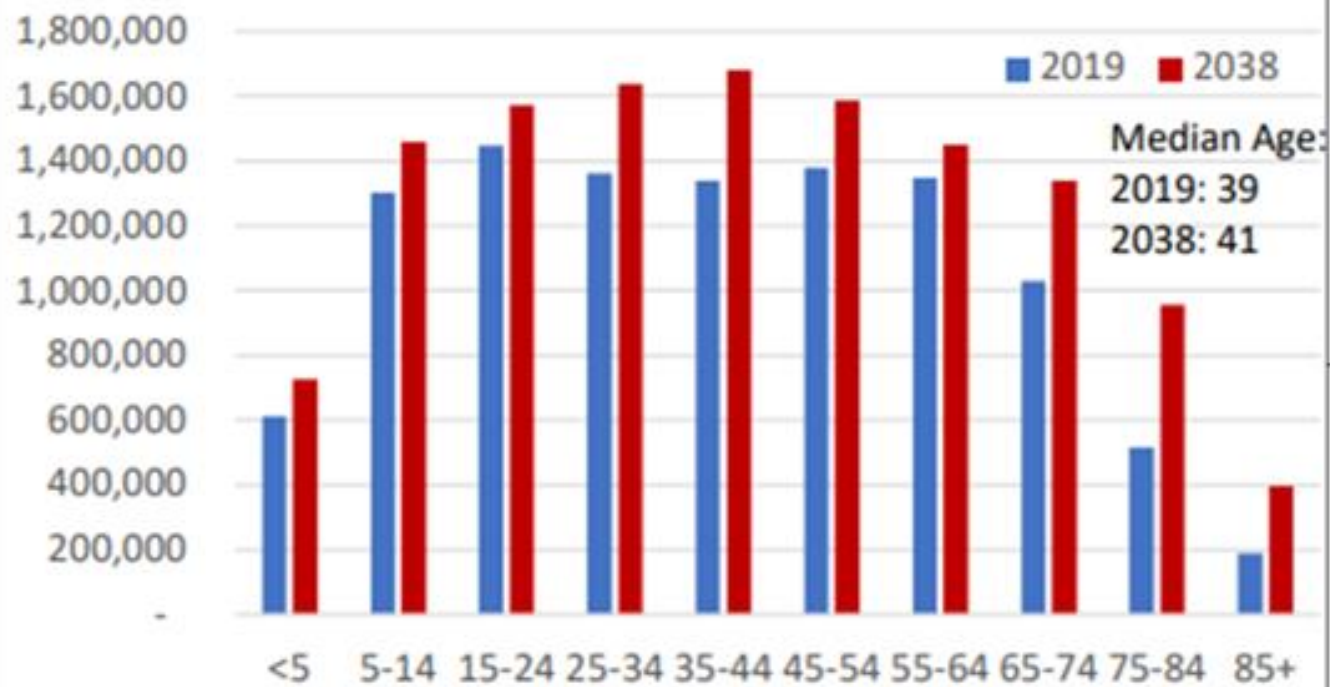
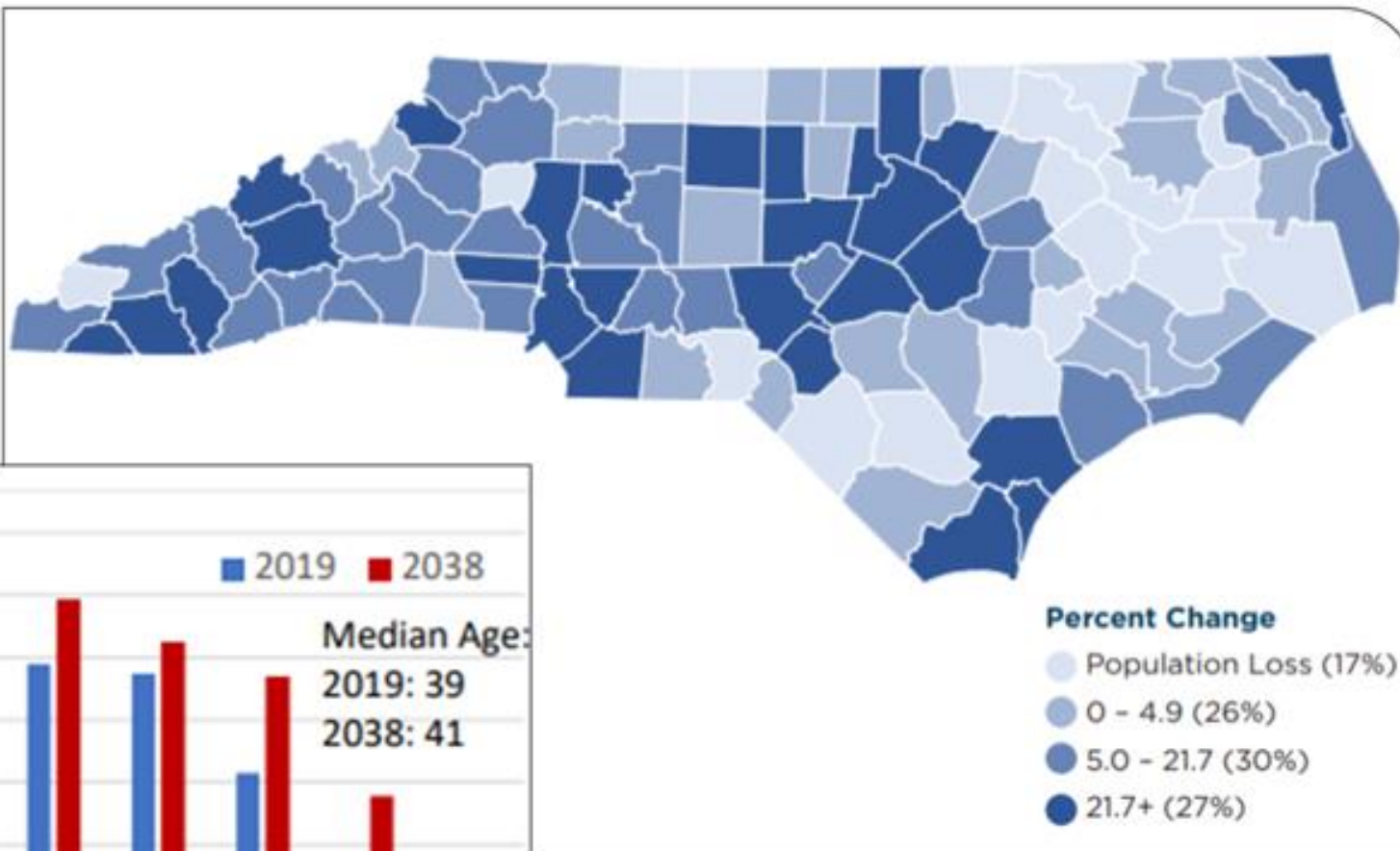

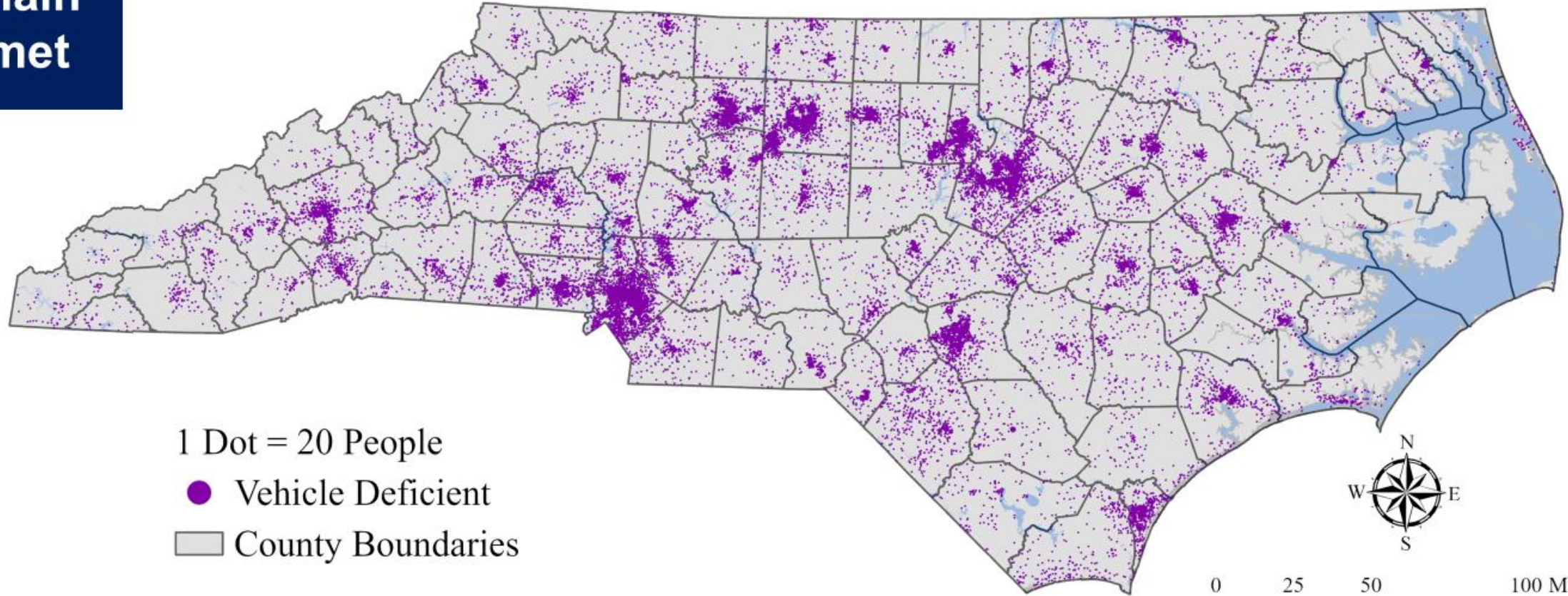
Our Population is Changing

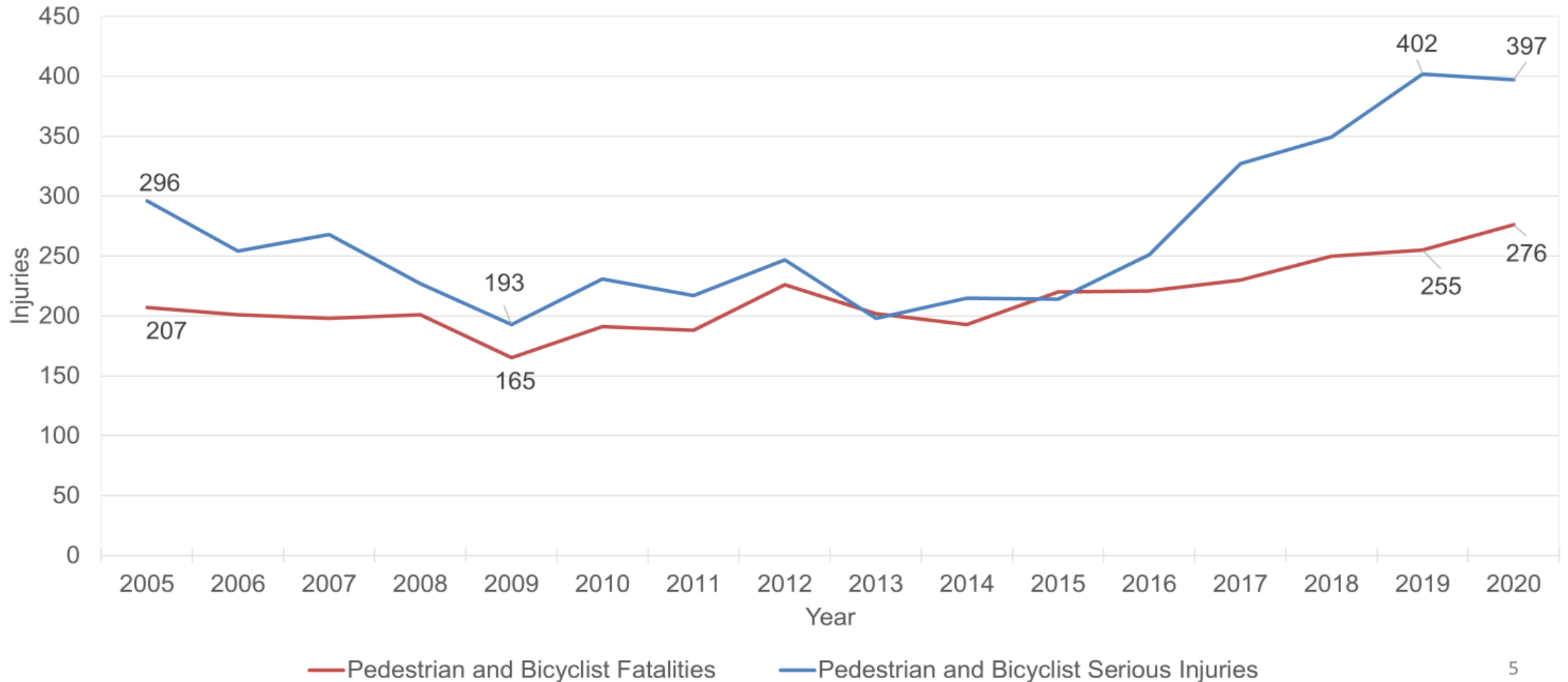

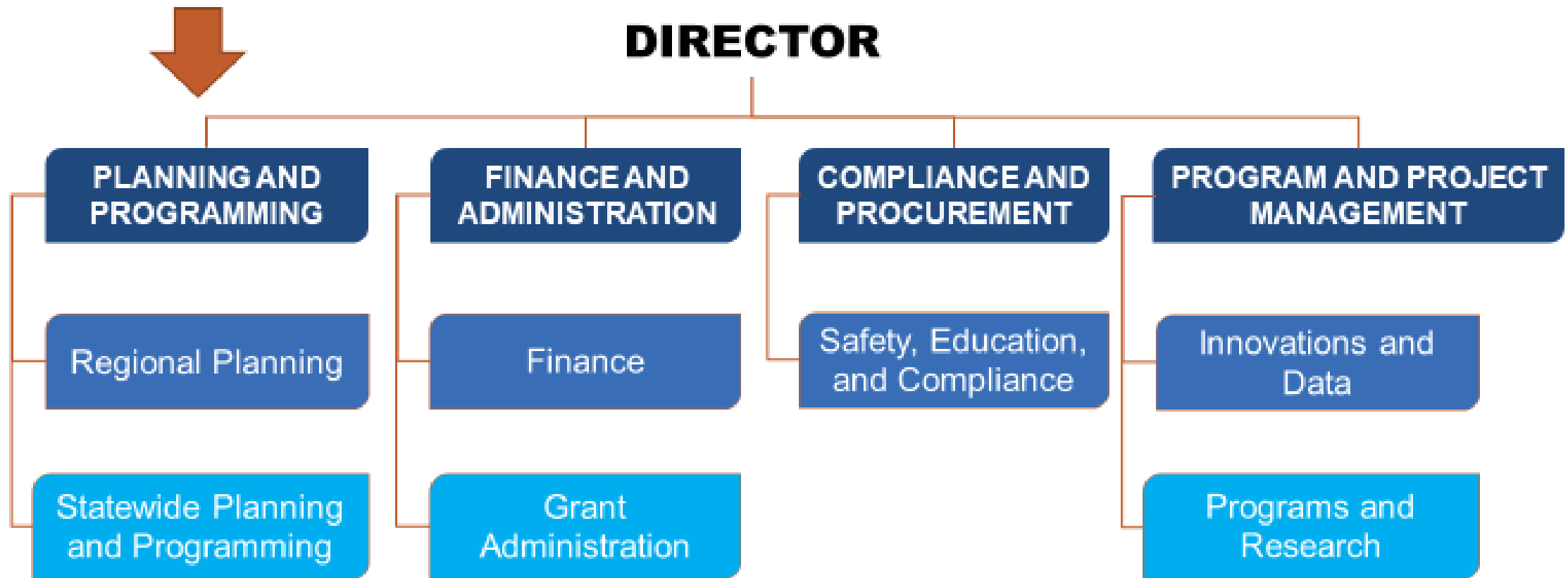

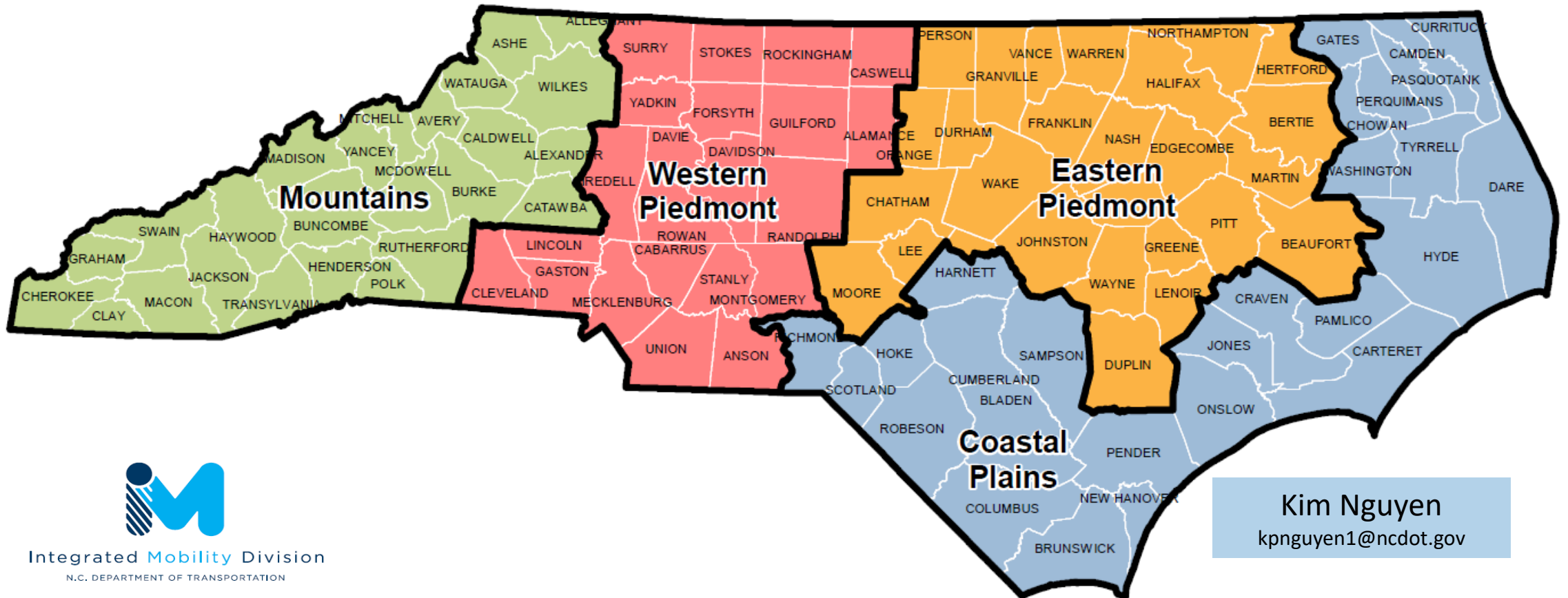
NC Bicycle & Pedestrian Safety Trends

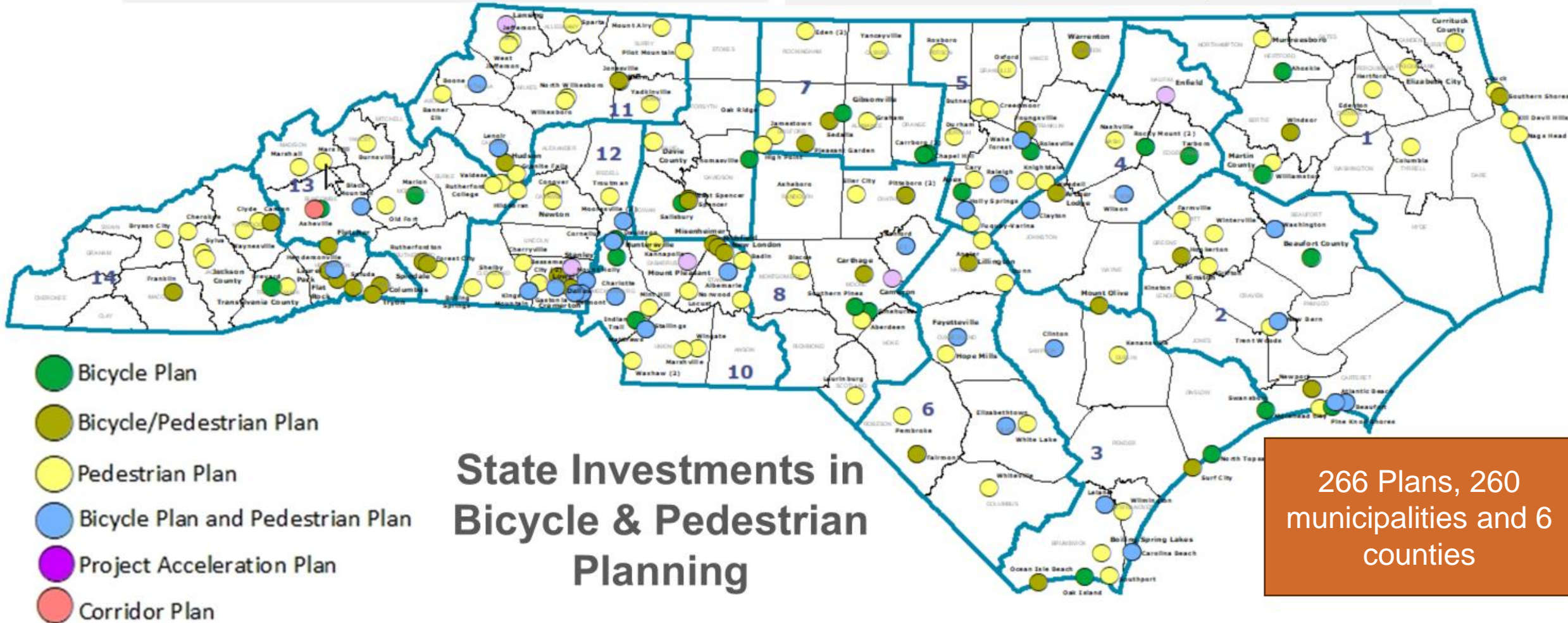

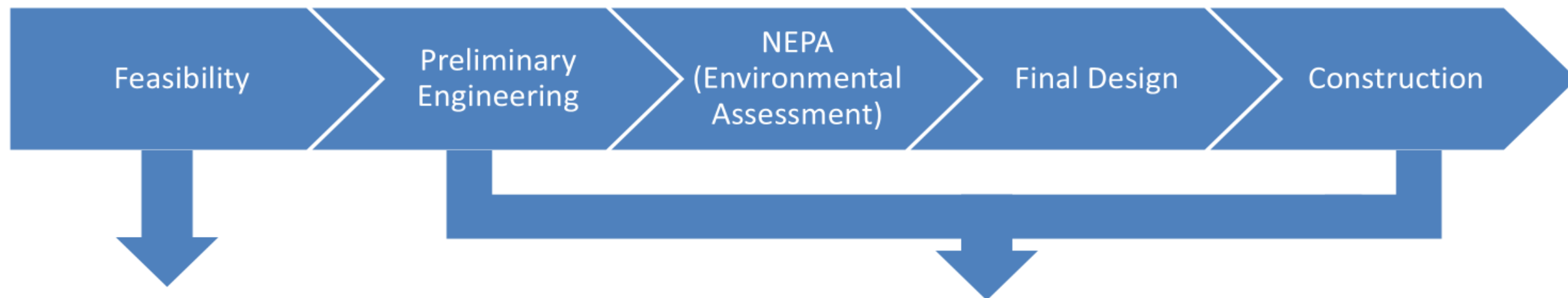

 - Discretionary Grants

Responsibilities of a Regional Planner

MM Consultation:

- Facilities guidance, facility selection, bike-ped guidebooks, recommended widths, buffer distances, considerations, best practices.
- NC Complete Streets Policy, STIP formula for bike-ped and public transit.

Planning Studies:

- Local plans administered through IMD, PGI, future programs.
- Feasibility studies and safety studies administered by IMD or NCDOT.
- Locally administered projects, steering committees.

General Coordination:

- Relationships with local agencies and personnel, knowledge sharing on regional MM activity and priorities, identifying need for grants, identifying need for special projects.
