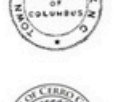

Overview

The Cape Fear Council of Governments (CFCOG) is a regional association of local governments in southeastern North Carolina and one of 16 regional councils in the state. Serving Brunswick, Columbus, New Hanover, and Pender counties and their 40 municipalities for over 50 years, the CFCOG is committed to providing regional solutions that improve the quality of life for the nearly 500,000 citizens we serve. First chartered in 1967-68 by Brunswick and New Hanover counties and their municipalities and expanded in 1970-71 to include Columbus and Pender counties and their municipalities, the CFCOG was designated by the state in 1972 as the Lead Regional Organization for the 4-county region (Region O) to consolidate many of the duplicative regional governmental functions into a single locally- focused and locally governed agency.

The Council's general membership is comprised of a delegation of local elected officials who are annually appointed from among each member jurisdiction's governing board. The primary responsibility of the appointed delegates is the election of the Council's officers and the remaining members of the Executive Committee at the annual General Membership meeting. Delegates also generally serve as their local government's primary point of contact for Council matters and act on any other matters brought before the general membership. The 9-member Executive Committee serves as the Council's governing board and, as a result, the CFCOG is governed by a select group of elected officials from across the four counties who are chosen by their peers to serve the greater good of the region.

The CFCOG serves the region by convening regional elected and appointed officials to achieve common purpose solutions; by providing planning, management, and other technical assistance and support to local governments of the region; and by administering a variety of state and federal programs and grants that benefit the citizens of the region.

In Fiscal Year 2023-24, the CFCOG operated an annual budget of approximately \$10.6 million, 72% (\$7.6 million) of which is from federal sources and another 20.7% (\$2.2 million) of which are state funds. The majority of the remainder of revenues are primarily fee-for-service contracts, grant matching funds, local project funds, and member dues. Over \$7.2 million was passed through to our community partners, including our county aging providers and workforce development contractors. Our unassigned fund balance in our General Fund is \$840,392, which represents 25% of our current annual operating expenditures and 7.9% of our total annual budget including pass-through funds.

The CFCOG operations are organized into two administrative departments and four programmatic departments: the Area Agency on Aging, Homeless Services, Local Government Services, and Workforce Development.

As part of a national network, The Cape Fear Area Agency on Aging works with the lead agency for aging services in each county providing advocacy, planning, program/resource development, information brokerage, funds administration, and quality assurance.

Homeless Services

Homeless Services at the CFCOG is the designated lead agency and collaborative applicant for the Cape Fear Homeless Continuum of Care (CFHCoC) for the City of Wilmington, Brunswick, New Hanover, and Pender Counties. The Cape Fear Homeless Continuum of Care (CFHCoC) is a collaborative group of service providers, local government agencies, health-care agencies, and other community stakeholders whose goal is to make homelessness in the region rare, brief, and non-recurring.

As lead agency, Homeless Services serves as the administrative home for the CoC, providing staff and fiscal sponsorship. The Homeless Services staff works closely with the CoC general membership and the Board of Directors to create best practices, improve data collection and quality, and strategically address needs within the community.

Homeless Services also serves as the Coordinated Entry and Homeless Management information System (HMIS) lead within the CoC. Coordinated Entry is a coordinated process designed to streamline the intake, assessment and referral process for homeless individuals in need of assistance to improve the overall system response and better serve those in need. As HMIS lead, Homeless Services staff are responsible for managing the HMIS database for the entire CoC. In addition, Homeless Services administers a Permanent Supportive Housing program that provides stable housing to twenty-six individuals.

2024 POINT-IN-TIME COUNT HIGHLIGHTS

The annual PIT Count was conducted to identify the needs of households residing in unsheltered locations (such as cars, streets, parks, etc.) as well as sheltered locations (emergency and transitional housing). The PIT Count aims to provide a snapshot of homelessness in our region, over the course of one night.

Responses are self-reported and/or observations and may not be representative of the entire population

The Local Government Services (LGS) department provides member governments with a wide variety in four broad categories: Management, Planning, Transportation, and Data & Mapping. The department provides knowledge, experience, and staffing to supplement and extend member government capacity to meet the needs of our communities.

MANAGEMENT SERVICES

Services provided include personnel and pay studies, codes of ordinances, human resources and financial consulting, infrastructure asset management planning, grant writing and administration, and training and retreats for elected and appointed boards.

PLANNING SERVICES

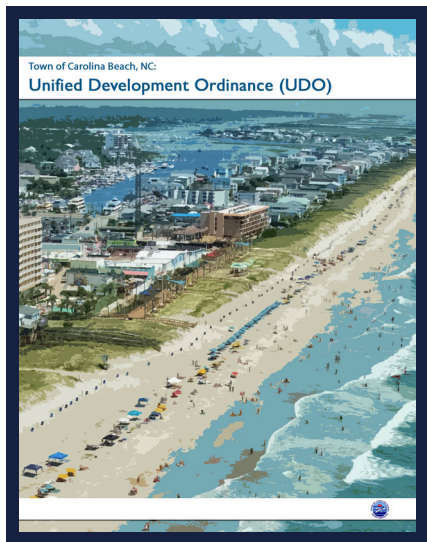
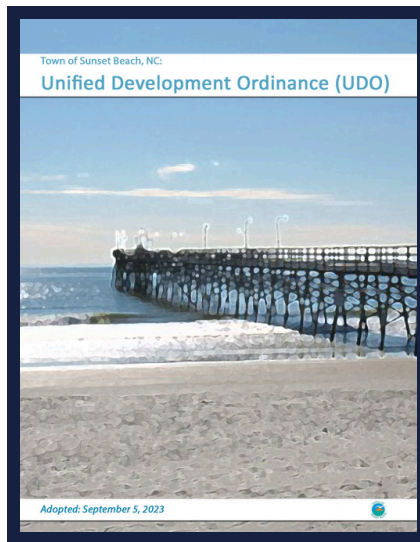
Services provided include long-range planning activities such as comprehensive plans, land use plans, hazard mitigation plans, park and recreation master plans, small area plans, and special studies; and current planning activities such as development review, development regulations, and zoning administration.

TRANSPORTATION SERVICES

Services provided include staffing and administration of the Cape Fear Rural Transportation Planning Organization (RPO), which provides transportation planning and advocacy for our non-metropolitan areas, as well as special transportation studies like corridor plans, bicycle and pedestrian plans, and parking and sidewalk inventories.

MAPPING, DESIGN, AND DATA SERVICES

Services provided include GIS mapping and spatial data analysis; GPS data collection and infrastructure mapping; 2-and 3-dimensional conceptual designs; and data access and management consulting. We develop and maintain several spatial databases of local facilities like sidewalks and parks, as well as serving as the regional State Data Center Affiliate.

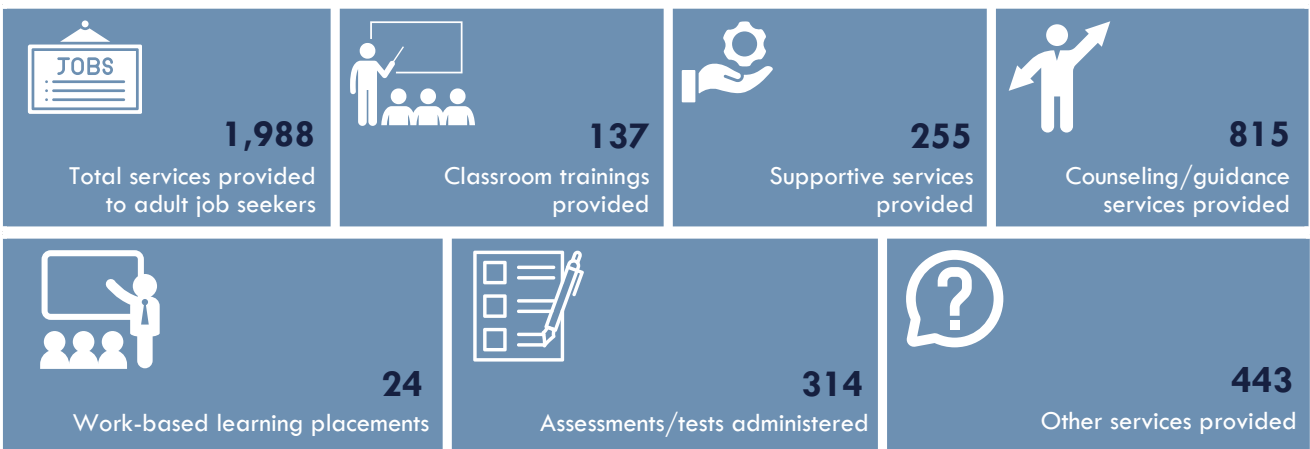
